Latest Version of Templates Used for Approval Documents

When a user generates an approval document that uses a [default approval template imported into the Document module](#), EPC now always uses the latest published version of the template, allowing organizations to rest assured that they always use the correct template for object approvals.

Identifier Column Sorting Options

Organizations can now choose the way their Identifier columns are sorted in the List page between:

Alphanumeric – EPC default

Numeric – New Sorting Option

With the numeric sorting, EPC will:

1. Group digit only values and sort them numerically and;
2. Order them by character length.

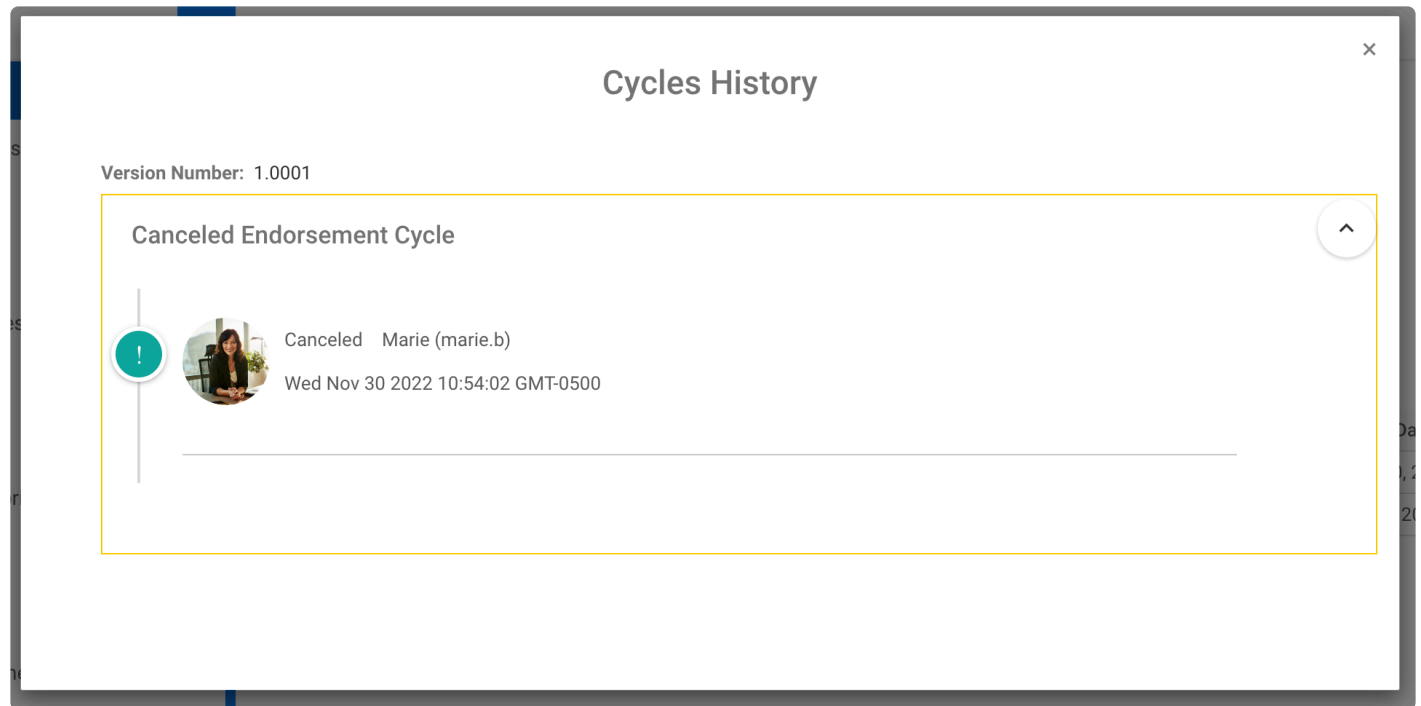

Endorsement Cycle History Enhancements

When a user opens an object's [Cycle History](#) pop-up window, the title of a canceled endorsement cycle has been changed to "Canceled Endorsement Cycle" and the border of the box is now yellow to allow users to easily differentiate between completed and canceled cycles.



Last Visited Button Improvement

When a user selects one of the objects in their search result page, the page of the selected object will be now found in the history drop-down list, when clicking on the [Last Visited Tabs](#) button.

FIXED ISSUES

Endorsement Cycle

Fixed an issue where user-written text in angle brackets would not appear in the comment section of an endorsement cycle after endorsing an object.

Email Links to Objects

Fixed an issue where links provided in emails sent to users when they had pending actions on objects did not redirect to the environment where the objects were located.

EPC Homepage

- Fixed an issue where users were not switched to the correct environment when accessing a copy/paste URL from the EPC homepage.
- Fixed an issue where configuring the external website widget in the EPC homepage with a shared URL of a document would fail when the document was an HTML file.

Audit Trail

- Fixed an issue where replacing a “File” type document with another document was not captured in the audit trail log (version was skipped)
- Fixed an issue where the audit trail log did not show a complete historical status change for endorsement cycles.

New Button – Set Creation

Fixed an issue where users would get an error when selecting an object then trying to create a new set using the “New” button.
